## 2. Advocacy

a) 2024 Priorities – The City of New Westminster (CoNW) approved the budget for the Active Transportation Network Plan (ATNP). Brad wants the CoNW to confirm which components of the plan will be implemented in the first two years as plans and actual implementation can differ.

According to the ATNP, year 1 (ie 2024) projects will include Boyd Street, 7th Street, 7th Avenue including Fader Street connection to the Central Valley Greenway and connections to Burnaby's priority network.

Action: Heidi will invite Gavin Hermanson or Mike Anderson of the CoNW to an upcoming meeting for an update of the ATNP.

b) Present at Council in Support of Active Transportation Network Plan - It is unclear whether this is still needed given that Council has passed the budget for the ATNP.

c) HUB SD40 Bike Friendly Buildings Report - No new information.

d) Youth Advocates - Heidi and Robert gave a presentation and a workshop about cycling at New Westminster Secondary School (NWSS). A next step could be to contact flaggers, who are part of Union <u>CSWU 1611</u> to ask if they would support improving safety for cyclists. Heidi contacted HUB Central to find out what HUB has done previously.

g) Pathway between Hume Park and Braid Station (behind Amazon facility) - Eden Rose is holding a chat on Sunday March 24 (at noon) at Take Five Cafe (202 East Columbia Street, Sapperon) to discuss establishing an alternative bike route on the north side of the Brunette River.
