Finalize position paper - July 4th (Jennifer)

Get endorsement from Van and Burnaby VACC Committees – (Lorraine)
Draft letter to go with position paper – August
Seek endorsement from outside independent organizations (native groups, those concerned with mobility, pedestrian groups etc) – August/September
Communicate that position paper will be coming to government agencies – Sept Send the position paper and lobby - Fall

4. New Business: FOI response

John's opinion is that if we send Richard's brief to MOTI that they will simply return the longer CH2M Hill report to VACC, indicating that MOTI has studied the issue and suggesting that no further work is needed.

Committee members agreed to review the CH2M report and to decide whether or not the Second Narrows Crossing paper needs substantive changes. If so, then we will make revisions and to the paper and resubmit to the VACC, Burnaby, Vancouver and NS committees for their endorsement. If no substantive changes are needed we'll continue to pursue the timeline identified in 3a.
