Re: Freedom of Information and Protection of Privacy Act Request for Access to Records - File # 20-105

Please see our responses to your clarification questions below.

- 1. Would multi-use paths be considered cycling infrastructure...Or just dedicated cycling lanes or facilities?
  - a. Yes. Please include financial information related to multi-use pathways. If the financial information is differentiated by path type, please indicate the path type in the spreadsheet information. We have added a "Path Type" column in Appendix A as an example.
- 2. Is the ask related to 2019-2024?
- a. Yes. For the 2019 fiscal year we are looking for both the budgeted and actual expenditures for cycling-related activities (infrastructure and operating). For the 2020-2024 fiscal years we are looking for only the budgeted amounts for cycling-related activities.
