Seaside South (Lisa)	 Looking at conditions along False Creek west from Olympic Village, through Vanier and Kits Park to connect with the Seaside Greenway routing at Balsam and Cornwall. The City is looking to improve the area from Cambie St to Burrard St with respect to active transportation concerns and has a stakeholder group looking at the area currently. We have Anthony from the Seaside South Working Group as our HUB rep in this group. Public consultations expected in October. A letter has been sent to the Parks Board over concerns expressed about an orange snow fence blocking cyclists just before Balsam St. This appears to be causing people to cycle on the sidewalk as they try to avoid having to deal with a busy intersection with no safe cycling infrastructure at Balsam and Cornwall. Park Board staff is looking into this.
