1. Meeting called to order at 19:05 hours.
2. Minutes of April 2018 to be adopted at June meeting.
3. There is no business from previous meeting.
4. NACTO Bike Infrastructure Workshop May 26, 2018.

HUB Vancouver is hosting a National Association of City Transportation Officials workshop on Bike Infrastructure Design.

Dan Millsip indicated that he has invited Langley City Council member Paul Albrecht to the event. Sarah Kikkert has expressed an interest to attend.

As in previous years, the Surrey and Maple Ridge committees will be joining us from 15:30 – 17:30 on Monday, May 28, at the south end of the Golden Ears Bridge where will have a table and tent set-up. We may see less bike traffic this year because of the removal of bridge tolls.

## 6. 20/20 Quick Fix Initiative

HUB Vancouver has initiated a friendly competition amongst the regional municipalities to make improvements to cycling infrastructure. The objective for each committee is to identify 20 quick fixes that their municipality can attend to this summer. HUB Langley has asked visitors to our Facebook page to help us identify deficiencies that they see in ToL and Langley City. Local committees will submit their lists to HUB head office by May 31 and HUB will then share the information with the respective engineering departments.

## 7. Action plan – interviews with Township and City council members.

In an effort to increase awareness of the importance of cycling infrastructure in Langley, this committee is reaching out to Township and City council members prior to the fall municipal elections. Dan and Tony met with Counsellor Petrina Arnason May 15 and had a very productive discussion. In our conversation, Counsellor Arnason suggested it might be useful to work with community groups such as the Healthier Community Partnership to promote cycling infrastructure as an integral part of healthy communities.

This committee will endeavour to conduct several more interviews in June.

## 8. Healthier Community Partnership – Michelle Truong

Given that Michelle Truong represents Fraser Health on this committee, she was able to share her perspective with us. Presently, the partnership is focussed on drug addiction, mental health and homeless issues in both Langleys. While cycling infrastructure is a very important component of a healthy community, the Healthier Community Partnership will likely find that the social issues they are dealing with are of a higher priority.

## 9. New business

Tony to contact Tammy Liu at ToL Engineering and ask for a meeting with Paul Cordeiro to discuss concerns such as the new bike lanes on the 208 St. overpass and a lack of cycling infrastructure from 208 St. to Carvolth bus loop.
