- PB: provided overview of options and explained that the PB approach to bicycling is "to not through" parks
- HUB: West to east, the diagonal at Balsam makes sense but needs on-street changes for transitional zone between park and road
- HUB: Separation of peds and bikes along Cornwall is desirable pedestrians should be at the curb due to parking, loading conflicts, etc.
- HUB: Alignment through the stretch between Balsam and Yew makes sense
- HUB: Yew Street needs clear sight-lines due to ongoing conflicts between modalities
- HUB: Option 2 creates conflicts at parking access off Arbutus. Pleased that reduction in number of vehicle entry points to the parking lot is being considered
- HUB: Several key nodes in the park are destinations (i.e. pool, waterfront, playground, restaurant, beach)
- HUB: Option 2 at Cornwall and Arbutus excludes cyclists who want to experience the park.
- HUB: Option 1 through the parking lot is better if it is a protected lane, not paintstripes
- HUB: Agrees there is some logic to not riding in front of the concession, but a bike route between the tennis courts and the restaurant along the service entry and then north through a gap in the trees should be considered
- HUB: The service entry and parking behind the Boathouse should be studied in depth
- HUB: Creelman intersection needs to be safe due to volume of pedestrians and children
- Park Board: Some trees along Arbutus are being considered for removal due to poor health and risk of failure
- HUB: Should examine different path alignments on street and in the park along Arbutus
- HUB: Loading/unloading from parallel parking is a problem if the bike path is at the curb



- HUB: If the path alignment is between the trees and the street along Arbutus bicyclists will feel excluded from the park
- HUB: Bikes should have reasonable access to the beach.
- HUB: On-street route on McNicoll (Option 2) is undesirable due to steep grade
- ENG: Not all cyclists are able-bodied, some have mobility challenges when not on a bike
- HUB: PB should provide or increase capacity of bike parking near destinations
- HUB: Bike route north of McNicoll should align with Ogden at north end; make use of existing paved section extending west from Ogden
- HUB: Option 1 in this area would be acceptable if path weaved through the trees not a straight line
- PB: Noted desire to preserve open space/picnic area
- HUB: A smooth transition into Vanier is needed from the route on Ogden; route through Vanier should be high priority
- HUB: City should reorganize the parking lot at the marina boat launch area in Vanier to make it safer.
- Park Board: Will share our recommended route at next meeting; to be scheduled before December 11
- HUB: May provide a letter of support if satisfied with the route recommended by PB staff
