84 Avenue plans

- Project approved
- We want it good for cycling present proposal is subpar requiring excess road crossing
- East side has main probs
 - Going with option B
 - Travelling west 2 crossings of 84 and extra distance
- Right turns at both ends does it really help traffic flow?
- Should have something on the south side
- City doesn't seem to be considering safe cycling
- Tim has made diagram with suggestions
- Will there be finger-pointing to cyclists with north side taking the park?
- Cutting into park is longer and requires navigation
 - Commuting vs recreational cycling balance
- 140 multiuse is bumpy with roots
- Surrey wants feedback: Tim sending the drawing this week and a letter next week

32 Avenue Interchange plans

- Meeting was held with Surrey regarding the project.
- Under the highway overpass the path narrows to (2.1 m for 2 way), well below recommended guidelines.
- Hoping to get some space back from traffic lanes
- Proposing a two way cycling path Tim has diagram and dimensions.
 - A couple of areas where bikes have little space on corner
 - There are options to make it smoother for bikes
 - Raised crossing
 - Double upped bike lane/multiuse at one point- change to one way cycle track

- Current construction on 32nd Ave does not include raised crossings
- Current project leaves gaps in the AAA network. Proposed scope change to fill gaps.
