a. Holdom Overpass-Cathy	Nothing new to report despite emailing May Phang

e. Overpass over Freeway-Peter	Peter asked why this happening given Kensington Overpass; discussion over a few details and that we too don't see as useful; Cathy to send report on to Peter; will bring up at TP discussion

a. Alison Gu-meeting in August with three of us-Cathy	She asked for info to support our desire for no more MUPs; Debbie/Cathy compiled/emailed info on negatives of MUPs mainly from BCAT Design Guide plus link to guide; James sent some videos by a planner explaining car centric approach which continues and detrimental to AT -Alison knew of our request for engineer in charge of cycling; She recently emailed us indicating she has requested such a position
b. HUB NW permanent widening of North Road (letter)-Cathy	Cathy sent letters exchanged b/t HUB NW & New West staff re making cycling lane from "Brunette River Path" 50-70 metres south to intersection to Hume Park permanent. HUB Bby sent letter of support to New Westminster as requested by HUB NW.

c. Douglas Connection-Moreno	Moreno his letter explained asking for a path connecting MacDonald to Douglas at Kitchener; Peter added that this was in a previous plan; suggested having a bulge along the boulevard to prevent parking/improve situation
d. Rush Hour Challenge- Jonathon	-invite city staff, Translink Staff and HUB staff may participate; have team members driving car vs cycling vs public transit and then see who's commute is the shortest. CoB declined to participate.

Peter also feels we need to stress that cycling is changing – huge uptake of ebikes & other e mobility plus how MUPs don't work; Debbie suggested summarizing points we gave in our TP feedback and mentioned pulling negatives on MUPs from BCAT Design Guide.
