- 192 street north and south of 60 Ave by Latimer Road Elementary School needs signage.
- 144 street from 104 Ave to 100 Ave, pave the shoulder to allow for bike path to connect the MUPs.

Fraser Highway Protected bike lanes

Robert posted a Facebook regarding two incidents on Fraser Highway and 144 street eastbound. Cars are making turns without yielding to cyclists contrary to posted signs. This issue was brought to HUB Cycling attention and discussed with ICBC.

Video footage was sent to First Student Bus on one of these incidents. The Safety Manager got back and said the incident was discussed with their drivers.

Risk Assessment

Robert shared a risk assessment that he completed for work for riding bicycles due to an incident while riding his bicycle for work purposes. Robert had nine hazards in this risk assessment e.g., Being struck by or striking vehicles, striking objects (potholes, tree branches) causing an accident, interaction with pedestrians, dogs, etc. that result in an impact, etc.
