- HUB State of Cycling Report update is out (Jesse)
 - Richmond staff offered to meet & discuss results
 - Jesse good opportunity Amy and Devyn will help to look through report to find something to talk about. Vincent is looking at TDM(?)
 - Action: Vincent, Amy, Devyn, Jesse, Victor to look through report in more detail. Everyone - try to attend the workshop. Jesse to ask Nathan to meet after the workshop
 - Devyn took a quick look at the report less percentage of people cycling
- Sharrows on River Rd between Shell & No. 5 Rd
 - Noted by Ivan
- Update on Bark Park & meeting with staff (Jesse)
 - o Jesse met with Nathan, Sonali and Miriam to talk about assessment ride report

- Staff planning to present to Council next week recommendation to maintain the bike path and widening trail around Crown Packaging. Engineering issue more than a property issue.
- Vincent WOONERF Road Dutch consider cars as guests of the road. Make drivers aware of the road (narrowing, curbless, install bollards, cars drive at a slow pace). A type of design/philosophy that could make sense for low-density streets.
- Devyn City is open and doing this in new developments but may not apply to this rural area, and it's not a high-traffic area. Could use some traffic-calming.
- Jesse Sonali city has a cycling plan, and there's limited resources, part of the reason why they don't want to add the additional route and put in traffic-calming.
- Devyn people who would use the alternate road route would be groups who are training. Maybe some signage would be enough to direct them to the alternate route. Would add 1km each way to take the road.
- Vincent would it be enough to just reduce speed limits through Bark Park?
- Devyn all trails in Richmond are 15km/hr
- Sheryl a lot of residents advocating for cyclists and vehicles to slow down
- Devyn is fencing still on the table? Jesse that's still the plan at Bark Park, but not enough space on the trail around Crown Packaging. Sound like City staff are on this and want to make both groups happy (dog folks and cyclists). **Action:** Still good to make our presence at the next meeting (May 28th 4pm) - Jesse will attend online.
- Sending someone to HUB's AGM, Sat Sept 21st, HUB's office in Gastown (see Cathy's email) Action: put on calendar, Jesse and Devyn will probably attend
- Update on RATC (Derek/Jesse)
 - Development at No 2 Rd and River Rd (where bridge comes into Richmond)
 MUP will be built around the development (see empty lot on map).
 - Sharrows on Shell Rd MUP
 - No 2 Rd MUP, Steveston to Williams, will start soon
 - Bike counters ordered and will be shipped soon
 - Closer to medium-term priorities of cycling plan, RATC will probably want to look at what facilities are needed (short-term priorities are almost done)
 - Update on No 3 Rd MUP (Devyn) Devyn approached Nathan re: No 3 Rd as people are already using it as a cycling path (desire path). Nathan looked into it, subject to approval, feasible from Ackroyd to Cambie Rd (wide enough), goal for 2025 capital projects. Section from Richmond Centre to Ackroyd, not wide

enough. Cambie Rd to Capstan Way, also limited width, but can remove some landscaping to put in an MUP. Some side roads off No 3 Rd, such as Brown Rd are also bikeable.

- Update on Great Blue Heron Way (Sheryl)
 - Had meeting with Translink. Agenda pedestrian overpass over Hwy 17, will be a
 huge project and several gov't levels. Also acknowledged the lack of bus stops
 along the route and Translink will look to increasing stops. Many members of the
 band do not have cars. Depends on budget, etc.
 - Devyn State of Cycling report also emphasized Tsawassen
- Update on council meetings (Sheryl)
 - Extending pilot project for e-scooters
 - Capital Projects 2024 asked questions (Devyn)
- Review action items from last meeting
 - Almost all done, only the long term plan for rapid implementation
- (time permitting) Review progress on the initiatives list
